Description

INVITATION TO BID FOR PROCUREMENT OF TWO UNITS UTILITY VAN

The METRO VIGAN WATER DISTRICT, through the 2025 CORPORATE FUND intends to apply the sum of TWO MILLION SIX HUNDRED PESOS ONLY (Php 2,600,000.00) being the ABC to payments under the contract for PROCUREMENT OF TWO UNITS UTILITY VAN. Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The METRO VIGAN WATER DISTRICT now invites bids for the above Procurement Project. Delivery of the Goods is required by 30 DAYS.

Bidders should have completed, within THREE (3) YEARS from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).

3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No.

5183.

4. Prospective Bidders may obtain further information from BIDS AND AWARDS COMMITTEE OF THE METRO VIGAN WATER DISTRICT and inspect the Bidding Documents at the address given below during 8:00 A.M to 5:00 P.M, Monday to Friday except holidays.

A complete set of Bidding Documents may be acquired by interested Bidders on July 09 to July 31, 2025 from the given address and website(s) below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of FIVE THOUSAND PESOS ONLY (Php 5,000.00). The Procuring Entity shall allow the bidder to present its proof of payment for the fees be presented in person

6. The METRO VIGAN WATER DISTRICT will hold a Pre-Bid Conference on JULY 17, 2025; 2:00 P.M at the MVWD Board Room, Burgos St., Brgy. IV, Vigan City, Ilocos Sur , which shall be open to prospective bidders.

7. Bids must be duly received by the BAC Secretariat through manual submission at the office address indicated below, on or before JULY 31, 2025, 2:00 P.M. Late bids shall not be accepted.

8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 14.

9. Bid opening shall be on JULY 31,2025, 2:00 P.M at the given address below .Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.

The METRO VIGAN WATER DISTRICT reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
